The Committee will meet in the President's Office at 2:00 p.m., Friday afternoon to plan the activities for the session. Those who can should attend.

Whenever students have need of medical service, call the President's office for permission to call a doctor during office hours. During other times call the doctor of your choice and notify the President's office in writing of your action within the next twenty-four hours. Otherwise, the cost of service will not be charged to the Health Service.

Recreational swimming will be held on Mon., Wed., and Friday from 3 to 4 P.M. Tank suits or regulation swimming suits must be worn. Additional information may be secured from the pool attendants regarding suits.

A student who finds it necessary to leave school before the close of the session should make arrangements with the Registrar for an honorable dismissal. The Textbook Library will be open every day from 1:00 - 2:00 P.M.

Students who expect to graduate from the two-year or four-year course at the close of this session should check with the Registrar not later than Thursday, July 25th.

Students who are earning credits for the renewal of their certificates should see the Registrar not later than Friday, July 26th.

Students will not be permitted to change their programs after Thursday, July 25th.

In order to drop a course, a student must secure a drop card from the Registrar.
