RUED, DAVID E. INTERVIEW

- S- 1941 Rued, David E. (1932 ). State Senator, District 13. Independent Republican, Aitkin, Minnesota.
  - 1979 Senator Rued discusses his personal background including his decision to major in Agricultural Education at the University of Minnesota.

Rued tells that while working as an Agricultural instructor, he decided to run for state representative in District 13B (1978). His close defeat in that election led him to pursue the vacated seat of Senator Winston Borden in District 13. The victory in that election put him in the senate.

Rued related his attitude toward government in general and his feelings on various specific legislation. Rued also told of the conservative nature of his district as well as emphasizing his own conservative beliefs.
